Questions & Answers

- 1. Is 23 CFR 667 required only for ER project funding or all grant funded projects going forward?
 - A: 23 CFR 667 is required for all federally funded projects on the federal aid roadway system.
- 2. Do we know when the HSIP awards are going to be announced?
 - A: We only know that they will be announced soon. The list has to be approved by management so the public announcement can be released.
- 3. Office of Federal Programs: do you know the approximate B/C cut-off for Cycle 11?
 - A: The B/C cut-off for Cycle 11 was 18.
- 4. Caltrans Internal Audit Office (CIAO): For agencies with grant awards equal to or greater than \$750K given payment upfront (not in arrears), would the SAR be required for the FY when payment given to agency?
 - A: A non-federal entity that expends \$750,000 or more during the non-federal entity's fiscal year in federal awards must have a single or program-specific audit conducted for that year in accordance with the provisions of this part.

To further expand on my answer, the code of federal regulation uses the term expends. The measure should start when your agency determines the cost has been incurred per their adopted Generally Accepted Accounting Principles https://www.ecfr.gov/current/title-2/subtitle-A/chapter-II/part-200/subpart-F/subject-group-ECFRfd0932e473d10ba/section-200.501

 - A: "No Adverse Effect"
